Year 11 GCSE Transition Guide August 2025

General Information for Parents/Carers

Kindly spend some time discussing the following important points with your daughter, helping her to reach her full potential at GCSE in St Mary's.

Attendance

Key to success at GCSE level is excellent <u>attendance</u> and <u>punctuality</u> at school. Parents/carers are encouraged to make appointments for their daughter outside normal school hours where possible and family holidays should not be booked during the school term. It is important to keep half days to a minimum.

Home Study

It is essential that students spend between 2-3 hours each evening during the week on home study. Your daughter will have a range of homework activities to complete for her GCSE subjects. Tasks will include research, written homework, learning, IT tasks and practical activities. To enable her to complete work to a high standard it is important that her home working environment is a quiet area, free from distractions including mobile phones and social networking computer sites.

Preparation for Learning

Your daughter must come to school each day fully prepared for learning including having all the correct subject books and equipment. Homework must be written into her diary at the end of each lesson and completed to a high standard for the next lesson.

Part time Jobs

Research clearly shows that students who have part time jobs do not reach their full potential at GCSE and 'A' Level. Please ensure your daughter doesn't have a part time job during the school week, as she needs time for homework and relaxation.

Use of School Diary

All pupils have been provided with a school diary, which is an essential part of school equipment.

- The diary includes important information regarding the school rules, procedures and policies. All parents/carers should read this information and sign the diary to acknowledge agreement.
- 4 Your daughter must record all her **Homework**, **Assessment Results and Attendance Record** in her diary and keep it free from graffiti.
- The diary can be used for communication between your daughter's teachers' and home. It is very important that you check the diary regularly and sign it at the end of each week.

GCSE Support Classes

Many subjects organise after school revision classes to support your daughter as she progresses through her GCSE course, in particular in preparation for GCSE module exams. Kindly ensure that she attends such classes, availing of the extra opportunities for her to succeed.

Examination Timetables and Repeats

When your daughter receives her Exam Timetable, please take time to go through it with her so that she fully understands what days and times her exams are at. Those students wishing to repeat GCSE examinations will be required to pay for the entry fee.

Assertive Mentoring Programme

A number of students, who are not reaching their full potential, will be selected for an 'Assertive Mentoring Programme'. They will have a daily Progress Report to be signed by their Mentor and parent/carer. If your daughter is placed on this programme, you will be informed in advance. This programme has proven to be a great success when we have the support of students and parents/carers.

Year 11 and 12 Assessments

Each Year 11 and 12 student will be awarded a Target Grade based on the outcomes from previous assessments and Baseline Data. This Target Grade will be used as a benchmark to identify pupil attainment and progress which will enable us to establish a **Personalised Performance Record** for each student. Class teachers will use five standardised department assessments at identified times throughout the year (see below). The School Based Computerised Assessment System (Assessment Manager) will be used by all departments to monitor pupil attainment and progress in Years 11 and 12.

Intervention strategies will be initiated for those students who have been identified as underachieving in a number of subject areas. The Leader of Learning (Curriculum), Mrs L Little, will liaise with Subject Leaders, Year Tutors and Form Teachers to coordinate the programme.

All parents/carers are encouraged to contact the school if they have any concerns about their daughter's progress and an appointment will be made for them to come to the school so that their concerns can be addressed appropriately.
